OUR HOUSE OF PORTLAND IN SOUTHEAST PORTLAND PROVIDES 24 HOUR SPECIALIZED NURSING CARE AND SERVICES IN A RESIDENTIAL CARE FACILITY FOR THOSE WITH ADVANCED HIV/AIDS WHO REQUIRE MORE INTENSIVE CARE. IN ADDITION TO HIV/AIDS AND RELATED PHYSICAL HEALTH ISSUES, MOST RESIDENTS ALSO SUFFER FROM MENTAL ILLNESS AND ADDICTIONS. A TOTAL OF 21 RESIDENTS AND THEIR FAMILIES WERE SERVED.
