IN ADDITION TO HIV/AIDS AND RELATED PHYSICAL HEALTH ISSUES, MOST RESIDENTS ALSO SUFFER FROM MENTAL ILLNESS AND ADDICTIONS. A TOTAL OF 21 RESIDENTS AND THEIR FAMILIES WERE SERVED.
